Connecting Science, Policy and Society as an Input for Decision Making: Rapid Assessment of Biological Diversity and Ecosystem Services of the Amazon Basin/Region

BACKGROUND

The Brazilian Government will hold, in Belém do Pará, on August 8 and 9, 2023, the Amazon Summit. Leaders and representatives of the eight countries that share the Amazon territory are expected to attend, with the objective of (i) discussing issues related to conservation, sustainable development, environmental protection and biodiversity preservation in the Amazon, (ii) produce a consensual position regarding the forest, which will be taken to future global discussions on climate action, and (iii) promoting the institutional strengthening of the Amazon Cooperation Treaty Organization (ACTO).

In addition, the so-called "Amazonian Dialogues" will take place in the days prior to the Summit, between August 4 and 6. The city of Belém will host a multiplicity of initiatives in the form of seminars, debates, side events, exhibitions and cultural events, with the aim of setting the agenda for the formulation of new strategies for the region. These initiatives will consist of what has been called "Amazonian Dialogues."

In this context, ACTO being one of the fundamental actors in both events, it has considered it essential to be able to present to the attending community the important efforts and contributions of the 8 Amazonian countries within the framework of its "Biological Diversity Program for the Amazon Basin/Region". Particularly with the implementation of one of its structural components that has to do with the contribution to science, expertise as well as research in the development of public policies of the Amazonian countries for the management of biological diversity in the Region, through the "Rapid Assessment of Biological Diversity and Ecosystem Services of the Amazon Basin/Region".

CONTEXT OF THE RAPID ASSESSMENT OF BIOLOGICAL DIVERSITY AND ECOSYSTEM SERVICES OF THE AMAZON BASIN/REGION

To better understand the status and trends of biodiversity and ecosystem services in the Amazon Region, as well as their interrelationships, opportunities and effectiveness of responses to current threats, ACTO coordinated a group of 118 experts from the Amazon countries to develop a Rapid Assessment on the state of biodiversity and ecosystem services in the Region during the years 2021 - 2023, following the methodology and conceptual framework of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services - IPBES, based on the compilation of information











and scientific evidence and other knowledge systems, including the traditional knowledge of Indigenous Peoples and Local Communities.

After the Assessment documents (Technical Document DT and Summary for Decision Makers SDM) were elaborated by the team of Authors under the guidance and orientation of the corresponding Coordinators, and delivered in their first version at the end of 2022, meeting one of the criteria of the IPBES methodology, they were made available in English and Spanish for comments from external experts from the eight (8) ACTO Member Countries. After reviewing the comments received from different social actors (governmental, private, academic and civil society), they were reviewed, systematized, and adjustments were made, resulting in the final documents (Technical and SDM), which were presented in a meeting to the Scientific Committee of the Assessment. In this context, the members of the Scientific Committee endorsed both documents under certain considerations which were appropriately included in the documents by the Authors and the Technical Support Unit.

It is expected that this important Assessment, as well as its products and results, will become strategic inputs that provide relevant, timely and rigorous information for decision making; strengthening the science, policy and society interface, with the objective of directing adequate sustainable development processes in the Region, and contributing to the implementation of effective public policies, based on findings, scientific and technical data for decision makers and other social actors related to the sustainable management of biodiversity.

OBJECTIVE

Present the results of the Summary for Decision Makers of the Rapid Assessment in the scenario of a high-level political event to position the work carried out as a strategic input that contributes the decision making in the Amazon Region.

OUTCOME

Present, socialize and create a space for the exchange of questions and answers in a strategic public linked to the decision-making processes and management of sustainable development in the Amazon Region, from the different spaces of action.
